0 Jump height must be noted on Utility and Open entries.

0 Open and Utility will be run by jump height in descending order.

0 The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when its class is called.

0 All dogs present must be on leash or confined to a crate except when being judged in the ring .

0 Crating space will be available on a limited basis. The trial site requires a tarp to be placed on the floor underneath your crates. Crates may be left overnight; however , the Shawnee Kennel Club and Body Renew will not be responsible for any lost or damaged items left at the show site.
